Judge Landis Saturday flued the Standard Oil company \$29,250,000 for accepting rebates from the Chicago & Alton railroad.

It was the greatest fine ever assessed against a private enterprise, by judicial proceeding, in the history of the world. In giving his decision Landis criticised the law to some extent and issued an order for a special grand jury to investigate the part the Chicago & Alton railroad had in the rebate crime.

By this decision the trust busting campaign has reached its climax. The company procured 1,800 carloads of property to be shipped at an unlawful, secret rate.





Posing as the Factor in Cheap Illumination, It Prospers by Most Unfair Methods

Washington, D. C., Aug. 5.—In a report submited to President Roosevelt by Herbert Knox Smith, commissioner of corporations, it now appears that the Standard Oil company, besides infringing upon the Elkins law under which it was fined, has been systematically raising the prices of oil and it's products for the past tweaty-five years. It had always been the claim of the Standard officials that only a large and powerful corporation like itself could supply the consumer with its products at as low prices as it was doing. It had further claimed that the price of oil was being steadily lowered by it's methods. Usoh of these statements is disproved by Smith's report, which in complete detail, shows the figures of price and profit exacted by the Standard.

Earnings Are 1790,000,000.

"It is substantially certain," says the report," that the entire net earnings of the Standard from 1852 to 1858 was a least \$170,000,000, and possibly much more. These enormous profits have been based on an investment worth at the time of it's original acquisition, not more than \$75,000,000."
