# Eide Leads Laborites to Primary Victory On the **National**

Picket Line

There IS a national picket line this week-a picket line five hundred thousand strong-half a million sternly silent men, deter coal will come forth from the bowels of the earth until a union con tract is signed.

And unless a contract covering the anthracite miners is signed by next Saturday night, this massive picket line will be swelled by one hundred and fifty thousand more

Bituminous coal mining is on of the country's basic industries More than one million tons of soft coal is consumed by industry each week of the year. There are less than twenty-six million tons above the surface of the earth at the

Already the giant subway systems of New York city have had their services curtailed 25 per cent by the city's Transportation Commission, in order to conserve the fast dwindling supply of soft coal. Many tug-boat and barge lines in New York Harbor have either completely suspended operations or have been greatly curtailed. All up and down the eastern seaboard small factories which were caught short on their coal supply have had to close their doors.

For more than seven weekssince April 1, when the old con-tract expired, negotiations between the union and the employers committee have been going on Up to Saturday night, May 6, the only point on which agreement had been reached was that the new contract—if and when—will run for two years.

The United Mine Workers' demands include all the conditions and wages which extract. They also demanded that the clause forbidding the calling of a strike or a lock-out during the life of the contract be eliminated. They want a closed shop.

# President Tobin on the Over-Road

The following tribute to the drivers who engaged in the long over-road strike in Omaha, Sioux City, Des Moines and other sections in the North Central District was written by President Daniel J. Tobin of the International Brotherhood of Teamsters. It appears as an editorial in the May, 1939, issue of the official magazine of the

The Middle Western States' strike which has been going on for months and which has been gradually coming to an end, is almost closed and another great victory has obtained for the officers and the unions that participated in this strike. During all the months of the strike, in which there were a couple of thousand men originally involved, there were less than a half dozen desertions from the ranks of the strikers. The local union members that were working assessed themselves and contributed as much as they possibly could to maintain the men that were on strike. The International Union paid the expenses of a general committee of about five members to enter into and conduct conferences and to a great extent manage the strike. The International Union also contributed as

much as it possibly could to help the strikers.

Most of the men on strike had not been members of our union more than one year ,but in all of my time and my years of service I have never known a better conducted strike or better union men than those that were engaged

in this conflict. If our members in the East and in the West who have been organized for years, could only understand the picture obtaining in cities like Omaha, Des Moines, and other such places, where for years our unions were kept out and crushed—I repeat, if our eastern and western members who have been trained as union men for years and who have been dealing with fair employers, could only understand the bitterness and the hatred against our unions by the employers of these Middle Western States, then they would have some realization of the quality of the men that engaged in the strike and of those (who handled the strike and helped to bring same to a success-ful ending. Again I repeat, that only with the co-opera-tion of our Chicago unions, our St. Louis unions, and our other strongly organized points could those men have won this great conflict even with all their fighting qualities.

other strongly organized points could those men have won this great conflict, even with all their fighting qualities which helped them to endure their privations and to undergo the sufferings that their families experienced during this long drawn out strike. There were many weeks in which some of those men on strike received only enough to keep body and soul together for themselves and their families, but those men never complained. They never cried for mercy. They never grumbled. They regretted having to fight this bitter fight, but remained steadfast to their obligation to the end. This is what brought about success. This, and the help of our strongly organized unions in other districts. We congratulate all those engaged in this conflict and we express our appreciation to the unions that were not engaged who so generously helped the men on strike.
